Course Description

It has become common in discussions of racism, sexism, and other forms of social inequality to talk about "social structures" and the "social construction" of race and gender. But what do these terms really mean? Sally Haslanger has become the most influential feminist philosopher working in analytic philosophy largely because of her contribution to clarifying these terms and locating them within a wider metaphysics of the social world. This seminar explores her contributions to social philosophy and metaphysics through a close reading of essays from her 2012 book, *Resisting Reality: Social Construction and Social Critique*, and more recent essays. Students will gain insight into key discussions in philosophy of race, philosophy of gender, social ontology, ideology critique, and the philosophy of the social sciences. We will also explore methodological questions of how philosophy should make sense out of the social world.
